Transfer of 470,000 ordinary voting shares to 16 employees upon completion of moratorium. The shares prior to the transfer were held in trust by BCS Development Pte. Ltd. ("BCS") on behalf of the employees pursuant to BCS Restructuring. As at the date of transfer, BCS is owned by Ong Bee Chip (50.0%), Ong Bee Song (33.3%), and Ong Chew Yong (16.7%). Accordingly, each of Ong Bee Chip and Ong Bee Song is deemed to have an interest in the Shares in which BCS has an interest, by virtue of section 7 of the Companies Act.
